

The sector must also address compliance with increasingly strict environmental requirements (pollution, C02 emissions, mobility, etc.) that will require greater investment.

The most developed markets will be faced, on the one hand, with major regulatory changes stemming from a clear trend towards restricting the use of internal combustion engines (ICE) and, on the other hand, with sizeable growth in R&D, manufacturing, marketing and use of electric vehicles, bolstered by manufacturers themselves and by public subsidies and aid for the manufacture and marketing of these vehicles.

The pursuit of innovative automated driving projects and new mobility services will drive investment in industry R&D, mergers and acquisitions and the development of joint ventures.



- Litigation: assistance in court proceedings at any instance (labor and judicial review courts, high courts, National Appellate Court, Supreme Court); advice on and appearances before the labor inspection authorities, mediation services and any other competent authorities
- Occupational risk prevention, health and safety at work: prevention systems, appointment of workers tasked with prevention activities, prevention plans, evaluations, training and information, etc.
